

Voting During the Pandemic

Be aware of your voting options
—Exercise your right to vote

This year, due to the COVID-19 pandemic, all voters in Connecticut are eligible to vote by absentee ballot or in person in the general election, held on November 3, 2020. *It's your choice to do what's best and safest for you and your family!*

MAKE SURE YOU ARE REGISTERED TO VOTE.

- Check the Secretary of the State's website: portal.ct.gov/sots
- The deadline to register to vote online, by postmarked mail, and in person is Tuesday, October 27, 2020.

ABSENTEE BALLOT VOTING

Did you know that the biggest reason that absentee ballots are rejected is that they have not been filled out completely or correctly!

- **Applications** for absentee ballots will be sent to all registered voters starting in September. If you need one, **contact your Town Clerk NOW**. Fill it out and get it submitted ASAP.
- Beginning the first week in October, **absentee ballots** will be sent out. When you get your ballot, fill it out completely and put it in the Official Ballot Drop Box outside of your town hall. You can also mail in your ballot.
- Only **complete** absentee ballots received before the close of polls on the day of the election will be counted.

VOTING IN PERSON

- Polls are open on November 3, 2020 from 6:00 am - 8:00 pm.

- Need a ride? Contact your Town Clerk to get the numbers for committees in your town offering rides to the polls.

2. If elected I pledge to support legislation that will stabilize the community non-profit system and ensure the highest standards of supports and safety for people with IDD.
3. If elected I pledge to protect the rights of all people with IDD to live and receive supports in their communities.

Special Act 19-12 AN ACT ESTABLISHING A TASK FORCE TO INCREASE EMPLOYMENT OPPORTUNITIES FOR PERSONS WITH DISABILITIES (#7093) *(Establishes a task force to study increasing employment opportunities for persons with disabilities and to establish financial incentives for businesses that employ persons with disabilities.)*

Public Act No. 19-49 AN ACT CONCERNING TRANSITIONAL SERVICES FOR CHILDREN WITH AUTISM SPECTRUM DISORDER (#7168) *(Ensures that school age children with autism spectrum disorder receive services from the Department of Developmental Services and are eligible for Medicaid coverage despite family earnings.)*

Public Act No. 19-184 AN ACT CONCERNING THE PROVISION OF SPECIAL EDUCATION (#7353) *(Protects teachers who make recommendations on behalf of students in PPT meetings; establishes a working group to study services needs in the gap between Birth to 3 and kindergarten; and requires a communication plan for alerting students who are deaf, hard of hearing or both blind or visually impaired and deaf of an emergency situation.)*
